Preschool Classes

Request for Enrollment Form

What can be expected in our Preschool classes? Utilizing developmentally appropriate curriculum, the children learn through play and have the opportunity to become successful, independent, self-confident, enthusiastic, inquisitive learners. We allow them to learn at their own pace and in the way best for them. Our goal is to develop good habits and attitudes, particularly a positive sense of self, which will make a difference throughout their lives. The various learning activities planned; the way their environment is organized; selection of toys and materials; their daily schedule and communication with the children are all designed to give each child a successful start in their classroom experiences and develop a love for learning!

Once these classes are full, we do maintain "Waiting Lists" for each class throughout the year and *if* a spot becomes available, contact is then made with those families and their child's enrollment will go forward at that time. Placement is a first come, first served basis.

- Preschool classes are for children that are 3 or 4 years of age by Sept. 1st of the current school year;
- Classes meet every Monday, Wednesday and Friday; 9:30 AM 12:00 PM/Noon;
- Rate is \$150 / month (the months of August & May are often prorated)
- Submission of our Non-Refundable Enrollment Fee is \$40 for a family's first child and \$25 for each additional child from the same family. These are <u>due at the time this form is submitted</u> which reserves your child a place in their age-appropriate classroom! We cannot / will not consider any child enrolled until the form(s) and fee(s) are received in the ECC office!
- Each class typically has 2 adults, a Lead Preschool Teacher and Classroom Aide; up to 10 children will be placed in each class;
- Our afternoon "Extended Care" option is offered to attending Preschool children;
 - Available on Mondays and/or Wednesdays from 12:00 PM 3:00 PM;
 - At an additional rate of \$15 / day, and is dependent on the actual number of Mondays and/or Wednesdays we are to be in session from month-to-month.
 - "Extended Care" If not initially chosen on this submitted "Enrollment Form", this option *can be added later*, as the school-year progresses; please request this for your child 2-3 weeks advance so we maintain required child-to-staff ratios in the afternoons!
 - Once requested, "Extended Care" is on-going versus a drop-in situation, and can be revised if needed at any point in the year.
 - Our program typically follows the Bartlesville public school calendar.
 - Our "Enrollment Agreement," which is a more detailed form, will be provided at a later date.
 - Each Preschool class teacher will have a small "Supply List" that is requested for each child to provide and will be provided at a later date.

We here at East Cross ECC will consider the acceptance of children with special needs on a caseby-case basis. Our staffing resources are very limited which limits our ability to meet the needs of some children.
